OCCUPATIONAL THERAPY RE-EVALUATION

Re-evaluations typically occur every 12 months during the regular treatment sessions and include components of the initial evaluation.

NOTE:

Therapy sessions include:

- 60 minutes of direct therapy and time for family/caregiver consultation, education, and required documentation.

Half-hour therapy sessions include:

- 30 minutes of direct therapy and time for family/caregiver consultation, education, and required documentation.
- Receipts will be provided for insurance filing at the time of service for evaluations and monthly for individual therapy.
- All evaluations and re-evaluations are routinely forwarded to the physician free of charge.

CANCELLATION POLICY:

Your appointment is time that we reserve specifically for you; however, with enough notice we are able to accommodate other clients when your schedule changes. Cancellations must be made 24 hours prior to your appointment. The voice message system is available 24 hours a day.

If we do not receive a 24-hour cancellation notice, you will be charged a no-show fee for your appointment. The no-show fee is 50% of the usual session charge.

NOTE:

If you submit your receipts for insurance reimbursement, no-show appointments cannot be submitted. Therefore, you will be billed directly for this fee and it will not be reflected on your monthly receipt.
